1. OVERVIEW

The purpose of this document is to establish rules governing the West Virginia Lottery's NASCAR Fast Track Powerball 2nd Chance Drawing. These rules supersede any other information, including printed informational brochures, How-To-Play brochures, web site information, radio, television, newspaper, or any other means of communications in regard to this promotion and associated drawings.

The Director of the West Virginia Lottery reserves the right to change or supersede any outlined rules to handle unforeseen circumstances. This promotion is void where prohibited by law.

Additional draw procedures associated with this drawing may be implemented at a later date as necessary. This promotion is void where prohibited by law.

2. PROMOTIONAL SYNOPSIS

a. CASH PRIZE AWARDS

Purchase of a West Virginia Lottery's Powerball draw ticket from May 18, 2025, through May 31st, 2025. The number of entries into the contest will be based on the dollar amount purchased per ticket.

\$1 – 1 Entry

Entries, as well as loyalty points, will be accumulated by scanning the barcode or manual entry of the barcode of the Powerball ticket, or purchasing tickets on the WV Lottery app or on wvlottery.com

You can enter two ways: on your computer or on your smart phone.

3. PROMOTION PRIZES AND DRAW DATES

a. CASH PRIZE DRAWING

Purchase any number of plays of West Virginia Lottery's Powerball, from May 18, 2025, through May 31, 2025, to be eligible. There shall be one (1) drawing. The drawing shall award fifteen (15) \$500 prizes.

4. HOW TO ENTER

BY WEBSITE

- A. Log into our website or complete the one-time registration process for the new WV Lottery website to enter on the Internet. The Lottery does not sell or use your information for any other purpose other than as a verification you are an individual, convenience for your entry into Lottery promotions and as contact information should you win. You will find the registration page at: **www.wvlottery.com**

Once logged into the West Virginia Lottery website, select the Play On tab at the top of the page, select Second Chance (3rd option down), and select Powerball under the Second Chance header. Follow the instructions to enter into the NASCAR Fast Track Powerball 2nd chance promotion.

BY MOBILE APP

- B. To enter on a smart phone, log into the iPlay app or complete the one-time registration process. Visit wvlottery.com or download our free WV Lottery app on your smartphone and follow the links to register. The Lottery does not sell your information for any purpose. Information you provide is over a secured connection and is maintained on a secure server. Visit wvlottery.com FAQs for more details. Information provided is used only for verification you are an individual, maintain your preferences, to allow online play, to enter Lottery promotions, and as contact information should you choose.

Download and install the free WV Lottery app on your smart phone. Log in using your registered email and password and then follow the instructions to enter into the NASCAR Fast Track Powerball 2nd chance promotion. Tickets must be purchased during the promotional entry period and tickets may be used only once per entry to enter the 2nd chance drawing.

Only valid internet/app entries will be accepted. Hand delivered, courier, emailed, facsimile, or mail entries will be disqualified.

ENTRY INFORMATION

- C. Entries are captured online by and will be maintained by Pollard Banknote.
- D. The number of entries will be based upon the per ticket submitted. Every \$1 spent on Powerball qualifies as one (1) entry into the drawing.
- E. Player information necessary for fulfillment (entrant's name, complete address, daytime phone number and e-mail address) will be associated with each entry.
- F. At the time of submission, the entry will be registered.
- G. The captured entries will be stored in a secured electronic file until the entry deadline.
- H. Once the valid entry period expires, the file will be prepared for the random selection process.

5. DRAWING PROCEDURES

a. CASH DRAWING

1. Pollard Banknote shall provide promotion drawing services for the West Virginia Lottery. The drawing shall be conducted in accordance with West Virginia Lottery procedures, promotion rules and regulations as provided to Pollard Banknote.
2. An independent auditor shall be present to verify that drawing procedures were followed.
3. Using a secure draw system, Pollard Banknote shall establish a file comprised of the unique/non-duplicated entry numbers from the electronic entries.
4. There shall be a total of One (1) grand prize drawing conducted. The drawing will be secure and;
 - A. Pollard Banknote shall be responsible for uploading the file of internet entries into the draw system and entering the criteria for the drawing.
 - B. Pollard Banknote shall initiate the selection process.
 - C. An output document shall identify the winners and alternates and provide for the disqualification of duplicate or ineligible entries. The output document shall be sent to the West Virginia Lottery via a secure FTP site and shall be given to the WV Lottery Drawing Manager or designee, and
 - D. The entries shall be evaluated by the West Virginia Lottery Drawing Manager or designee to determine that the entrants meet the qualification/validations criteria and general rules.
 - E. Using the Secure Draw System fifteen (15) entries from the drawing pool shall be selected as prize winners, which will include fifteen (15) \$500 winners. The West Virginia Semi Finalists we be entered into a national draw with fifteen (15) other semifinalists with the chance to win over \$1 million worth of prizes and an all-expense paid VIP trip for two (2) to Pheonix for the NASCAR Cup Series Championship.
5. An additional thirty (30) "alternate" entries for the drawing shall be randomly drawn from the remaining entries in the event that an entry does not meet the required criteria to qualify as a winner or in the event a selected winner declines to accept the prize or is unreachable.
6. Limit one (1) prize per person, per drawing. Any entry selected with a duplicate name subsequent to that person's first entry shall be disqualified for the drawing.

6. VALIDATION

a. CASH DRAWING

The listing of selected winners and alternates shall be securely sent to the West Virginia Lottery immediately after the verification and drawing processes. The list of all winners and alternates

must include winner's first and last name, address, email, working daytime phone number, entry identification number and ticket transaction number.

The West Virginia Lottery shall verify that the selected winners are valid entries. If a winner's submission is deemed invalid for any reason, the next subsequent alternate shall be used. The West Virginia Lottery shall then notify all winners by telephone and/or email to provide information on claiming their prize. Winners MUST respond to the initial West Virginia Lottery phone/email contact within forty-eight (48) hours following the initial contact attempt or the winner shall forfeit the prize, and the prize shall be awarded to the next alternate. Winner must respond with claimant information within five (5) business days or prize(s) may be forfeited.

Should an alternate be selected, the West Virginia Lottery shall make contact by telephone and/or email and that alternate shall have forty-eight (48) hours to respond. In the event the alternate cannot be reached, this process shall be repeated until the prize is awarded.

7. FULFILLMENT

a. CASH DRAWING

Cash prizes to be awarded in the drawing shall be provided by the West Virginia Lottery, funded by the West Virginia Lottery's unclaimed prize fund and fulfilled by the West Virginia Lottery upon winner claim.

8. GENERAL RULES

- By submitting an entry, entrant agrees to the rules set forth in this document, West Virginia Lottery Rules, and West Virginia State and Federal Law.
- Must be at least 18 years of age to enter the promotion.
- Purchase any amount of West Virginia Lottery's Powerball® game through June 30, 2025, to be eligible. There shall be one (1) drawing. The drawing shall award fifteen (15) \$500 prizes. The West Virginia Semi Finalists we be entered into a national draw with fifteen (15) other semifinalists with the chance to win over \$1 million worth of prizes and an all expense paid VIP trip for two (2) to Pheonix for the NASCAR Cup Series Championship.
- West Virginia Lottery game tickets entered must have been sold by a West Virginia Lottery Commission Licensed Lottery agent (past or present) or by the West Virginia Lottery Commission to receive a valid ticket entry.
- Only online entries shall be accepted. Hand delivered, courier, emailed, facsimile, or mail entries shall be disqualified and shall not be returned and neither the West Virginia Lottery nor its designee shall be held responsible for such disqualified entries.
- The player is responsible for providing accurate and current contact information during entry. The West Virginia Lottery is not responsible for player information that is outdated, omitted, or when a player is unreachable after being selected a winner. It is

the responsibility of the player to provide and maintain up-to-date and accurate, name, address, email, and valid daytime phone number in the player portal.

- No player shall be selected for more than one (1) prize for the drawing.
- Prizes over \$601 are subject to Federal and State standard withholdings. Prizes are subject to collection of unpaid Child Advocacy and unpaid State taxes.
- Notification of disqualification shall not be provided to the player.
- Neither the West Virginia Lottery nor any of its retailers or vendors are responsible for entering qualifying tickets on behalf of a player.
- The West Virginia Lottery and its designated agent(s) are not responsible for failure of an electronic device, communication or any technical aspect of the entry process that may fail due to human error by the entrant or malfunction of a mobile device or computer.
- Draw results shall be posted via the web at wvlottery.com following the drawing and on our social media.
- Should a player be selected for a NASCAR Powerball Playoff Promotion trip package, that prize shall be treated as West Virginia Lottery game winnings. Winner must be clear of any payments owed to the West Virginia Child Advocacy Office or West Virginia State Tax Department immediately after receipt of NASCAR Fast Track Powerball 2nd Chance Drawing winnings. If winner owes West Virginia Child Advocacy Office or West Virginia State Tax Department after prize receipt, that winner shall be disqualified and an alternate shall advance to the NASCAR Powerball Playoff Promotion without receiving any NASCAR Fast Track Powerball 2nd Chance Drawing winnings. No cash equivalent shall be awarded in place of a trip package prize. The West Virginia Lottery is not the administrator of the NASCAR Powerball Playoff Promotion nor is responsible for any NASCAR Powerball Playoff Promotion prizes. Please see attached NASCAR Powerball Playoff Promotion overview, prize description, and terms and conditions.
